9) MASTERS/Center for Fathers and Families - Updated Invoice

- The Centers for Fathers and Families after school program has elected to leave our school in December 2024.
 Note that all Masters items (smart boards, printers, etc.) will stay at NJB.
- We contracted with them for our ELOP plan, which was a huge amount of money (around \$500,000 a year) funneled through NJB. This money was to be used before or after school as an extended learning opportunity program.
- Centers for Fathers and Families sent NJB an invoice saying they were not paid.
- Previously, money was being spent in ways it should not have been spent. There was a lack of governance here.
- Effectively, we got to 2024-2025 with \$12,000, which is effectively nothing for salaries.
- We started 2023-2024 without a signed contract. CFF were working in good faith without a contract during this time. The only people who can sign contracts are SCUSD officials.
- **Mrs. Wiley wants to make it clear that she does not believe there was malicious intent here**, but multiple contracts were signed like this without oversight, one for INK 916, one for Kona Ice, etc.
- We owed \$270,000 for the 2023-2024 school year.
- We owed \$85,000 for summer school.
- CFF renegotiated with a 2023-2024 contract for \$180,786.45 and \$62,700 for summer school because of changes in student numbers.
- Last year's bill is being paid with COVID funds from this year.
- Thank you Melissa for helping us to handle this situation with amazing integrity. You are truly appreciated.
